In continuation of this Ministry's sanction letter of even number dated 8<sup>th</sup> December, 2022, I am directed to convey the sanction of the President to release the funds of ₹ 88.685 crore (Rupees eighty eight crore sixty eight lakh and fifty thousand only) to the National Highways Logistics Management Limited (NHLML) for MMLP projects under NHAI-Investment Scheme for the NH works entrusted to NHLML during the Financial Year 2022-23.

2. The above expenditure is debitable to the following head under Demand No.86 - Ministry of Road Transport & Highways for the year 2022-23:-

3. There is a Budget provision of Rs. 1,13,400.00 crore under the above head. Out of which, ₹ 2,500.00 crore has been allocated to State PWD being executed for NHDP-IV projects and ₹ 1,09,802.315 crore has already been release to NHAI and including this sanction letter ₹ 1,097.685 crore has been allocation to NHLML for MMLP. After this release, the total balance amount under NHAI-Investment head shall be Nil as on date.

4. The accounts of National Highways Logistics Management Limited (NHLML) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.

5. Compliance of the provisions of OM (F.No.12(13)-B(W&M)/2020) dated 25.05.2022 issued by Budget Division, Department of Economic Affairs, Ministry of Finance, has been ensured.”.
