After release of this amount of Rs.200.00 crore to NHAI, an amount of ₹ 1,220.00 crore is reserve/balance in the head of account.

5. The accounts of National Highways Authority of India (NHAI) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.
