I am directed to say that an amount to Rs.2000 crore was released to NHIDCL being CNA vide this Ministry letter of even number dated 24.04.2023 through DDO (W&A) bill No. CP-15 dated 24/04/2023 for NH works for the current financial year 2023-24 under the Head of Account 5054- Capital Outlay on Roads & Bridges (Major Head), 01, National Highways (Sub Major Head), 01.337 Road Works, 03 National Highways Original Works, 03.01 National Highways Original Works - General - Financed from Central Road and Infrastructure Fund, 03.01.73 Infrastructural Assets.

2. Under the above Head, a total provision of Rs.7462.30 crore was at BE 2023-24 stage. Out of this total fund, an amount of Rs.5462.30 crore was released to NHAI and Rs.2000 crore was released to NHIDCL during the current financial year.
