
3. All the ROs of MORTH are requested to fulfill following additional conditions mentioned below before making any payment for the works of EI&ISC :-

- Prior to booking of further expenditure against any work consequent to the allocation being made, the concerned RO shall inspect the particular work. The RO should satisfy w.r.t. the progress of the work.
- Project Zone should also depute officers from HQs to inspect the works from time to time while inspection of other NH works are undertaken by them.
- No payment should be made for the works which are not inspected by RO/Project Zone.
- The RO/Project Zone should also check the quality of the work. Necessary instruction may be given to concerned State/ UT in this regard for rectification if any.
- The payments under EI&ISC works should only be made after completely satisfying the progress of work.
- ROs shall also ensure compliance to all observations/ shortfalls.


