I am directed to convey the sanction of the President to allocate and release the funds of **₹ 600.00 crore (Rupees six hundred crore only)** under Bharatmala Priyojana - Tribal Area Sub Plan Scheme (from CRIF) to National Highways & Infrastructure Development Corporation Limited (NHIDCL) for NH works entrusted to NHIDCL during the Financial Year 2023-24.

2. The above expenditure is debitable to the following head under Demand No.86 - Ministry of Road Transport & Highways for the year 2023-24:-

3. There is BE provision of Rs.6,870.90 crore under Bharatmala Priyojana-TSP (from CRIF). Out of this, an amount of Rs. 3000.00 crore is being allocated/release of NHA and after release of this amount of Rs. 600.00 crore to NHIDCL, an amount of Rs. 3,270.90 crore will be in balance in the head of account.

4. It shall be ensured that the expenditure against above sanction is incurred only on the NH works entrusted to NHIDCL by the Ministry.

5. Compliance of the provisions of OM (F.No.12(13)-B(W&M)/2020) dated 25.05.2022 issued by Budget Division, Department of Economic Affairs, Ministry of Finance, has been ensured.”.

6. The accounts of National Highways & Infrastructure Development Corporation Limited (NHIDCL) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.


