In continuation of this Ministry's sanction letter of even number dated 19th April, 2024, I am directed to convey the sanction of the President to release the funds to the National Highways Authority of India (NHAI) for NHAI investment under Major Head 5054 (2nd Quarter release) for NH works entrusted to NHAI during the Financial Year 2024-25 as per details below :

2. The above expenditure is debitabte to the following head under Demand No.86 - Ministry of Road Transport & Highways for the year 2024-25:-

5054 - Capital Outlay on Roads & Bridges (Major Head)
01 - National Highways (Sub Major Head)
01.190 - Investment in Public Sector & Other Undertakings (Minor Head)
01 - National Highways Authority of India
01.00.54 - Investment

3. There is a VOA provision of ₹ 70,000.00 crore under the above head for the financial year 2024-25. Out of which, ₹ 930.00 crore has been allocated to State PWD being executed for NHDP-IV projects ₹ 100.00 crore has been released to NHLML and ₹ 29,400.00 crore has already been released to NHAI. After release of this amount of ₹ 29,400.00 crore to NHAI (total: ₹ 58,800.00 cr.), the total balance amount under NHAI-Investment head shall be ₹ 10,170.00 crore as on date.

4. The Section Officer (W&A) of the Ministry will be the Drawing and Disbursing Officer for the payment of this amount. Amount of ₹29,400.00 crore (Rupees twenty nine thousand four hundred crore only) may be credited in RBI E-Kuber CNA account of CS-NHAI No. 10698001001-National Highways Authority of India.

5. NHAI should submit the utilization certificate to MoRTH and follow the Rules as contained in 149(iii), iv, 150, 150(5) and 151(2) of GFR. Utilization certificate amounting to ₹ 22,237.00 cr. has been received from NHAI against the releases made on 19.04.2024 amounting to ₹ 29,400.000 Crore.
6. The Accounts of National Highways Authority of India (NHAI) shall be open to inspection by the Sanctioning Authority and Audit, both by C&AG and Internal Audit by the Office of Pr. CCA
7. Compliance of the provisions of OM (F.No. 12(13)-B(W&M/2020) dated 25.05.2022 issued by Budget Divison, Department of Economic Affairs, Ministry of Finance, has been ensured.
8. This issues with the concurrence of Finance Wing vide their note No.#56 dated 18.07.2024.


