Sub:- Revised allocation of funds for incurring expenditure on sanctioned SARDP-NE related works on first-come-first-serve basis during the financial year 2022-23-reg.

Sir,



In continuation of this Ministry's sanction letter of even number dated 6th March, 2023, I am directed to convey the sanction of the President of India to allow ROs/RPAOs to admit expenditure against sanctioned SARDP-NE works (including Arunachal Package) being executed by States under SARDP-NE head on **purely first come first served basis** henceforth during 2022-23 out of the total overall allocation of **Rs. 1,910 Crore** for States; subject to the condition that office of Principal CCA shall ensure that overall corresponding expenditure under SARDP-NE head is not exceeded at any point of time, as these would ensure that bills pertaining to well performing States are cleared without any delay and there is no gestation period involved on account of the requirement to enhance their outlay at any stage in case the States allocation is/are fully exhausted, as long as the total corresponding outlay under SARDP-NE head for States for entire Country is not fully exhausted.

2. The above amount/expenditure is debitable to the following head under Demand No.86 - Ministry of Road Transport & Highways for the year 2022-23 :-

5054 - Capital Outlay on Roads & Bridges (Major Head)
01 - National Highways (Sub Major Head)
01.337 - Road Works (Minor Head)
05 - Special Accelerated Road Development Programme in
North Eastern Areas financed from National Investment
Fund
05.00.53 - Major Works

3. It shall be ensured that the expenditure against above sanction is incurred only on the works sanctioned by the Ministry under SARDP-NE.
