
3. There is a BE provision of ₹ 1,20,000 crore under the above head for the financial year 2024-25. Out of which, ₹ 1700.00 crore has been allocated to State PWD being executed for NHDP-IV projects, ₹ 500.00 crore has been released to NHLML and ₹ 1,17,670.00 crore has already been released to NHAI. After release of this amount of ₹ 130.00 crore to NHAI (total: ₹ 1,17,800.00 cr.), the total balance amount under NHAI-Investment head shall be ₹Nil as on date.

4. The Section Officer (W&A) of the Ministry will be the Drawing and Disbursing Officer for the payment of this amount. Amount of **₹130.00 crore (Rupees one hundred thirty crore only)** may be credited in RBI E-Kuber CNA account of CS-NHAI No. 10698001001- National Highways Authority of India.

5. NHAI should submit the utilization certificate to MoRTH and follow the Rules as contained in 149, 150 and 151 of GFR. Utilization certificate amounting to ₹ 1,11,536 cr. has been received from NHAI against the releases made on 19.12.2024 amounting to ₹1,17,500.000 Crore.
6. The Accounts of National Highways Authority of India (NHAI) shall be open to inspection by the Sanctioning Authority and Audit, both by C&AG and Internal Audit by the Office of Pr. CCA
7. Compliance of the provisions of OM (F.No. 12(13)-B(W&M/2020) dated 25.05.2022 issued by Budget Division, Department of Economic Affairs, Ministry of Finance, has been ensured.
8. This issues with the concurrence of Finance Wing vide their note No.#235 dated 24.3.2025.


