2. The above expenditure is debitable to the following head under Demand No.86 - Ministry of Road Transport & Highways for the year 2022-23:-



Out of which, an amount of Rs.235.00 crore has been allocated to States/UTs and after release of this amount of Rs.2,000.00 crore to NHIDCL, an amount of ₹ 5,791.20 crore is reserve/balance in the head of account NH(O)-NE.

4. It shall be ensured that the expenditure against above sanction is incurred only on the NH works entrusted to NHIDCL by the Ministry.

5. The accounts of National Highways & Infrastructure Development Corporation Ltd. (NHIDCL) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.

25.05.2022 issued by Budget Division, Department of Economic Affairs, Ministry of Finance, has been ensured.”.
