There is total fund provision Rs.61,677.00 Crore, under NH(O)-General(from GBS) for the financial year 2024-25, out of which Rs.61,194 crore(including instant proposal) has been allotted for States/UTs/NHIDCL/NHAI/NHML. After release of this amount Rs.483 crore will be in reserve/balance in the head of account.

4. It shall be ensured that the expenditure against above sanction is incurred only on the NH works entrusted to NHIDCL by the Ministry.

5. The accounts of National Highways & Infrastructure Development Corporation Ltd. (NHIDCL) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.
