Out of which, an amount of ₹521.30 crore has been allocated to States/UTs and ₹2,000.00 crore has been released to NHIDCL and after release of this amount of ₹3,000.00 crore to NHIDCL, an amount of ₹ 2,504.90 crore is reserve/balance in the head of account NH(O)-NE.

4. It shall be ensured that the expenditure against above sanction is incurred only on the NH works entrusted to NHIDCL by the Ministry.

5. The accounts of National Highways & Infrastructure Development Corporation Ltd. (NHIDCL) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.
