In continuation of this Ministry's sanction letter of even number dated 8<sup>th</sup> May, 2023, I am directed to convey the sanction of the President to allocate and release additional funds of **₹ 400.00 crore** (Rupees four hundred crore only) under Bharatmala Priyojana - work under Road Wing/State PWDs/NHIDCL/BRO Scheme to National Highways & Infrastructure Development Corporation Limited (NHIDCL) for NH works entrusted to NHIDCL during the Financial Year 2023-24 as detailed given below :

2. The above expenditure is debit to the following head under Demand No.86 - Ministry of Road Transport & Highways for the year 2023-24:-

5054 -Capital Outlay on Road & Bridges (Major Head)  
01 -National Highway (Sub - Major Head)  
01.190 -Investment in Public Sector & Other Undertakings (Minor Head)  
01 -National Highways Authority of India  
01.06 - Bharatmala Priyojana - financed from CRIF -works under Road Wing/State PWDs/NHIDCL/BRO  
01.06.54 -Investment"

3. There is RE provision of Rs.2,400.00 crore under Bharatmala Priyojana. Out of which ₹ 1299.60 crore has been allocated to States and ₹700.00 crore has been released to NHIDCL. After release of this amount of ₹ 400.00.00 crore (total:Rs. 1100.00 crore) to NHIDCL, an amount of ₹0.40 crore will be in balance in the head of account.

4. It shall be ensured that the expenditure against above sanction is incurred only on the NH works entrusted to NHIDCL by the Ministry.

5. Compliance of the provisions of OM (F.No.12(13)-B(W&M)/2020) dated 25.05.2022 issued by Budget Division, Department of Economic Affairs, Ministry of Finance, has been ensured."
