2. The above expenditure is debitible to the following head under Demand No.86 - Ministry of Road Transport & Highways for the year 2023-24:-

5054 -Capital Outlay on Road & Bridges (Major Head)
01-National Highway (Sub - Major Head)
01.796 -Tribal Area Sub Plan (Minor Head)
03 -Bharatmala Priyojana-Tribal Sub Plan - works under Road
Wing/State PWDs/NHIDCL/BRO financed from CRIF Fund
03.00.73 -Infrastructural Assets

3. There is RE provision after 1st supplementary of Rs.3,925.00 crore under Bharatmala Priyojana-TSP (from CRIF). Out of this, an amount of Rs. 3000.00 crore has already been released to NHAI and Rs. 800.00 crore has been released to NHIDCL. After release of this amount of Rs. 125.00 crore to NHAI(total Rs.3,125.00 crore), Nil amount will be in balance in the head of account.

4. It shall be ensured that the expenditure against above sanction is incurred only on the NH works entrusted to NHAI by the Ministry.




