
2. The above expenditure is debitable to the following head under Demand No.86 - Ministry of Road Transport & Highways for the year 2024-25:-

Out of which, ₹ 500.00 crore has been allocated to State PWD being executed for NHDP-IV projects and ₹ 100.00 crore is being released to NHLML for MMLP through this sanction letter. After this release, the total balance amount under NHAI-Investment head shall be ₹ 1,19,500 crore as on date.

4. The accounts of National Highways Logistics Management Limited (NHLML) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.
