- 01 - National Highway (Sub Major Head)
- 01.337 - Road Works (Minor Head)
- 05 - Special Accelerated Road Development Programme in North Eastern Areas financed from National Investment Fund
- 05.00.73 - Infrastructural Assets

3. Out of total BE allocation of ₹ 4,500.00 crore under SARDP-NE for the financial year 2024-25, an amount of ₹ 520.00 crore has been allocated to States/UTs. After release of this sanction letter of ₹500.00 crore, an amount of ₹ 2980.00 crore is reserve/balance in the head of account SARDP-NE.
