I am directed to convey the sanction of the President to allocate and release funds of Rs.200.00 crore (Rupees two hundred crore only) under NH(O)-TSP Scheme to National Highways Authority of India (NHAI) for NH works entrusted to NHAI during the Financial Year 2024-25.

2. The above expenditure is debitable to the following head under Demand No.86 - Ministry of Road Transport & Highways for the year 2024-25:-

01	National Highway (Sub - Major Head)
01.796	Tribal Area Sub Plan (Minor Head)

3. It shall be ensured that the expenditure against above sanction is incurred only on the NH works entrusted to NHAI by the Ministry.

3. The total VOA provision under NH(O)-TSP (from GBS) for the financial year 2024-25 is ₹ 944.76 crore. Out of which an amount of ₹ 350.00 crore has been allocated to NHIDCL. After release of this amount of ₹ 200.00 crore to NHAI, an amount of ₹ 744.76 crore is reserve/balance in the head of account NH(O)-TSP-GBS.

4. The accounts of National Highways Authority of India (NHAI) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.

5. Compliance of the provisions of OM (F.No.12(13)-B(W&M)/2020) dated 25.05.2022 issued by Budget Division, Department of Economic Affairs, Ministry of Finance, has been ensured."
