In continuation of this Ministry's letter of even number dated 10<sup>th</sup> September, 2024, I am directed to convey the sanction of the President to allocate and release funds of ₹129.00 crore (Rupees one hundred and twenty nine crore only) under JICA to National Highways & Infrastructure Development Corporation Ltd.(NHIDCL) for EAP works under JICA counterpart entrusted to NHIDCL during the Financial Year 2024-25 as detailed below.

3. The total BE provision under EAP JICA Counterpart for the financial year 2024-25 is ₹ 800.00 crore. An amount of ₹ 90.00 crore has been allocated/released to NHAI and ₹ 8.00 crore to States. After release of amount of ₹429.00 crore to NHIDCL(including instant proposal), an amount of ₹ 273.00 crore is reserve/balance in the head of account.

4. It shall be ensured that the expenditure against above sanction is incurred only on the EAP works under JICA entrusted to NHIDCL by the Ministry.

5. The accounts of National Highways & Infrastructure Development Corporation Limited (NHIDCL) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.

6. Compliance of the provisions of OM (F.No.12(13)-B(W&M)/2020) dated 25.05.2022 issued by Budget Division, Department of Economic Affairs, Ministry of Finance, has been ensured.”.


