I am directed to convey the sanction of the President to allocate and release funds of Rs. 2,700.00 crore (Rupees two thousand seven hundred crore only) under NH(O)-NE Scheme (from GBS) to **National Highways & Infrastructure Development Corporation Ltd. (NHIDCL)** for NH works entrusted to NHIDCL during the Financial Year 2024-25.

2. The above expenditure is debitable to the following head under Demand No.86 - Ministry of Road Transport & Highways for the year 2024-25:-

3. There is total BE provision of ₹ 9,000 crore under NH(O)-NE(from NIF) for the financial year 2024-25. After release of this amount of Rs.2,700 crore to NHIDCL, an amount of Rs.6300 crore will be in reserve/balance in the head of account.

4. It shall be ensured that the expenditure against above sanction is incurred only on the NH works entrusted to NHIDCL by the Ministry.

5. The accounts of National Highways & Infrastructure Development Corporation Ltd. (NHIDCL) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.

6. Compliance of the provisions of OM (F.No.12(13)-B(W&M)/2020) dated 25.05.2022 issued by Budget Division, Department of Economic Affairs,



Ministry of Finance, has been ensured.”.
