2. The above expenditure is debitable to the following head under Demand No.86 - Ministry of Road Transport & Highways for the year 2023-24:-

3. There is BE provision of Rs.1,400.00 crore under Bharatmala Priyojana. Out of which ₹ 540.50 crore has been allocated to States and ₹400.00 crore has been released to NHIDCL. After release of this amount of ₹ 300.00.00 crore to NHIDCL, an amount of ₹159.50 crore will be in balance in the head of account.

4. It shall be ensured that the expenditure against above sanction is incurred only on the NH works entrusted to NHIDCL by the Ministry.

6. The accounts of National Highways & Infrastructure Development Corporation Limited (NHIDCL) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.
