In continuation of this Ministry's letter of even number dated 20<sup>th</sup> February, 2025, I am directed to convey the sanction of the President to allocate and release funds to **National Highways Authority of India (NHAI)** for incurring expenditure under **NH(O)- TSP - GBS** scheme for NH works entrusted to NHAI during the Financial Year 2024-25 as detailed below:-

2. The above expenditure is debitable to the following head under Demand No.86 - Ministry of Road Transport & Highways for the year 2024-25:-

3. There is total RE provision (After 2<sup>nd</sup> sup) of ₹ 2162.71 crore under NH(O)-TSP -GBS for the financial year 2024-25. Out of which Rs.147.90 crore has been allotted for States/UTs for NH(O) works including IRQP/PR works and Rs.2014.81 crore has been allotted to NHAI including the instant proposal of Rs.14.81 crore. After release of amount of Rs.14.81 crore to NHAI, balance under the head will be nil.

4. It shall be ensured that the expenditure against above sanction is incurred only on the NH works entrusted to NHAI by the Ministry.




