I am directed to convey the sanction of the President to allocate and release funds of ₹6000.00 crore (Rupees six thousand crore only) under NH(O)-General Scheme to NHAI for NH works entrusted to NHAI during the Financial Year 2024-25.

2. The above expenditure is debitable to the following head under Demand No.86 - Ministry of Road Transport & Highways for the year 2024-25:-

3. There is total VOA provision of ₹ 25,065.22 crore under NH(O)-General (from GBS) for the financial year 2024-25. Out of which Rs.8000 crore has been allotted for States/UTs and Rs.1,100 crore has been allotted to NHIDCL. After release of this amount of Rs.6000 crore to NHAI, an amount of ₹ 9,965.22 crore is reserve/balance in the head of account.

4. It shall be ensured that the expenditure against above sanction is incurred only on the NH works entrusted to NHAI by the Ministry.

5. Compliance of the provisions of OM (F.No.12(13)-B(W&M)/2020) dated 25.05.2022 issued by Budget Division, Department of Economic Affairs, Ministry of Finance, has been ensured.”.

6. The accounts of National Highways Authority of India (NHAI) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.
