In continuation of this Ministry's letter of even number dated 20<sup>th</sup> December, 2024, 6<sup>TH</sup> July, 2024 and 4<sup>th</sup> February, 2025, I am directed to convey the sanction of the President to allow ROs/RPAOs overall allocation of Rs.1,550 Crore under OR (Contract Maintenance), SR (N), FDR(N), FDR(C), "Pending Claims / Liabilities under OR for Previous Years" and "Pending Claims / Liabilities under FDR for Previous Years" sub-heads of M&R head during 2024-25, with **booking of expenditure on First Come First Serve basis, subject to the condition that O/o Pr. CCA may be requested to ensure that State / UT -wise settlement of pending claims / liabilities under OR / FDR for previous years does not exceed the State / UT - wise limit indicated in Letter No. RW/G-23012/01/2024-W&A dt 04.02.2025 read in conjunction with Letter No. RW/G-23012/01/2024-W&A dt 06.07.2024**
