3. There is total BE provision of ₹ 42,047.78 crore under NH(O)-General (Other Scheme) for the financial year 2023-24. Out of which ₹ 20,629.00 crore has been allotted to States and Rs. 5787.70 crore has been released to NHAI. After release of this amount of Rs.1000.00 crore to NHIDCL, an amount of ₹ 14,631.08 crore is reserve/balance in the head of account.

4. It shall be ensured that the expenditure against above sanction is incurred only on the NH works entrusted to NHIDCL by the Ministry.

5. Compliance of the provisions of OM (F.No.12(13)-B(W&M)/2020) dated 25.05.2022 issued by Budget Division, Department of Economic Affairs, Ministry of Finance, has been ensured.”.

6. The accounts of National Highways & Infrastructure Development Corporation Limited (NHIDCL) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.
