
2. The above expenditure is debitable to the following head under Demand No.86 - Ministry of Road Transport & Highways for the year 2023-24:-

01 Work under Road Wing  
01.02 Other Schemes

3. There is total 1<sup>st</sup> Supplementary provision of ₹ 44,475.22 crore under NH(O)-General (Other Scheme) for the financial year 2023-24. Out of which ₹ 27,795.00 crore has been allotted to States, ₹ 10,787.70 crore to NHAI, ₹ 54.746 crore to Shipping and ₹ 1,017.00 crore has been allocated to PR/IRQP[NH(O)]. After release of this amount of ₹ 1000.00 crore (total ₹2,500.00 crore) to NHIDCL, an amount of ₹ 2320.774 crore is reserve/balance in the head of account.

4. It shall be ensured that the expenditure against above sanction is incurred only on the NH works entrusted to NHIDCL by the Ministry.

5. Compliance of the provisions of OM (F.No.12(13)-B(W&M)/2020) dated 25.05.2022 issued by Budget Division, Department of Economic Affairs, Ministry of Finance, has been ensured.”.
