3. The total RE provision under EAP JICA Counterpart for the financial year 2024-25 is ₹ 564.00 crore. An amount of Rs.429.00 crore has been allocated/released to NHIDCL and Rs.8.00 crore to Road Wing. After release of amount of Rs.127.00 crore to NHAI(including instant proposal), an amount of ₹ nil is reserve/balance in the head of account.

4. It shall be ensured that the expenditure against above sanction is incurred only on the EAP works under JICA entrusted to NHAI by the Ministry.




