I am directed to convey the sanction of the President to allocate and release funds of Rs. 900.00 crore (Rupees nine hundred crore only) to **National Highways & Infrastructure Development Corporation Ltd. (NHIDCL)** under **NH(O)-General Scheme** for NH works entrusted to NHIDCL during the Financial Year 2025-26.

2. The above expenditure is debitable to the following head under Demand No.86 - Ministry of Road Transport & Highways for the year 2025-26:-

3. There is total BE provision of ₹ 61,392.37 crore under NH(O)-General (from GBS) for the financial year 2025-26. Out of which Rs.14,110 crore has been allotted for States/UTs and Rs.6400 crore has been allotted to NHAI. After release of this amount of Rs.900 crore to NHIDCL, an amount of ₹ 39,982.37 crore is reserve/balance in the head of account.

4. It shall be ensured that the expenditure against above sanction is incurred only on the NH works entrusted to NHIDCL by the Ministry.

5. The accounts of National Highways & Infrastructure Development Corporation Ltd. (NHIDCL) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.


