Madam/Sir,

In continuation of this Ministry's letter of even number dated 28th January, 202, I am directed to convey the sanction of the President to allocate and release funds of Rs.350 crore (Rupees three hundred and fifty crore only) to National Highways & Infrastructure Development Corporation Limited (NHIDCL) under National Highways (Original) scheme for NH works entrusted to NHIDCL during the Financial Year 2024-25 as detailed below:-

2. The above expenditure is debitable to the following head under Demand No.86 - Ministry of Road Transport and Highways:-

5054 - Capital Outlay on Roads & Bridges (Major Head)
01 - National Highway (Sub Major Head)
01.337 - Road Works (Minor Head)
01 - Road Wing
01.02 - Other Schemes
01.02.73 - Infrastructural Assets

3. There is RE/2nd sup provision of Rs.81,909.37 crore under NH(O) -General (From GBS) for the financial year 2024-25. Out of this, an amount of Rs.46,308.51 crore has been allocated to NHAI, Rs.33000 crore to States PWDs, Rs.50.86 crore to M/o Shipping and Rs.2550 crore to NHIDCL (including the instant proposal of Rs.350 crore). After release of this amount of Rs.350 crore to NHIDCL, balance under the head will be nil.

4. It shall be ensured that the expenditure against above sanction is incurred only on the NH works entrusted to NHIDCL in the Head of account.

5. The accounts of NHIDCL shall be open to inspection by sanctioning authority and audit, both by the C&AG and Internal audit by the office of Pr.CCA.
6. Compliance of the provisions of OM (F.No.12(13)-B(W&M)/2020) dated 25.05.2022 issued by Budget Division, Department of Economic Affairs, Ministry of Finance, has been ensured.”.
7. This issues with the concurrence of Finance Wing vide their Note No.#15 dated 21.3.2025.
8. The Section Officer (W&A Section) will be Drawing and Disbursing Officer in connection with the amount sanctioned above. An amount of Rs.350 crore (Rupees three hundred and fifty crore only) may be credited in RBI E-Kuber NHIDCL -CNA Account No.10698001002 under Road Works through electronic transfer in favour of National Highways and Infrastructure Development Corporation Limited, (NHIDCL), New Delhi.


