3. The total BE allocation under NH(O)-TSP(from CRIF) for the financial year 2024-25 is ₹ 2538.10 crore. Out of which Rs.2505.00 crore has been allotted to States/UTs/NHIDCL/NHAI/NHML(including instant proposal). After release of this amount ₹ 33 crore is reserve/balance in the head of account NH(O)-TSP.

4. The accounts of National Highways & Infrastructure Development Corporation Limited (NHIDCL) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.

5. Compliance of the provisions of OM (F.No.12(13)-B(W&M)/2020) dated 25.05.2022 issued by Budget Division, Department of Economic Affairs, Ministry of Finance, has been ensured."
