2. The above expenditure is debitible to the following head under Demand No.86 of the Ministry of Road Transport & Highways for the year 2025-26:-

3. There is total BE outlay of ₹ 4555 crore under Maintenance and Repairs Scheme for the financial year 2025-26. An amount of Rs.2400 crore has been allocated/released to NHAI, Rs.250 crore to BRO and Rs.1178 crore to State PWD, Rs.530 Crore (including instant proposal) has been allocated for NHIDCL. After release of this amount, ₹ 197 crore will be in reserve/balance in the head of account.

4. The Section Officer (W&A Section) will be Drawing & Disbursing Officer in connection with the amount sanctioned above. An amount of ₹200.00 crore only (Rupees two hundred crore only) may be credited in RBI E-Kuber CNA Account No.10698001011 - Maintenance of NHs to NHIDCL through electronic transfer.

6. The amount should be spent for the schemes sanctioned under the head indicated in para 2 only. No expenditure should be booked/ incurred above the financial limit prescribed in each sanctioned job.

7. *The accounts of National Highways & Infrastructure Development Corporation Ltd. (NHIDCL) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA".*

8. Compliance of the provisions of OM (F.No.12(13)-B(W&M)/2020) dated 25.05.2022 issued by Budget Division, Department of Economic Affairs, Ministry of Finance, has been ensured.”.
