

I am directed to convey the sanction of the President to allocate and release of funds of **Rs.35.00 crore (Rupees thirty five crore only)** to **National Highways Authority of India (NHAI)** for EAP works under JICA counterpart entrusted to NHAI during the Financial Year 2025-26:-

2. The above expenditure is debitable to the following head under Demand No.86 - Ministry of Road Transport & Highways for the year 2025-26:-

3. The total BE provision under EAP JICA Counterpart for the financial year 2025-26 is ₹ 440.00 crore. An amount of Rs.80 crore has been allocated/released to NHIDCL and Rs.5.00 crore to State PWD. After release of amount of Rs.35.00 crore to NHAI(including instant proposal), an amount of ₹ 320 crore is reserve/balance in the head of account.

4. It shall be ensured that the expenditure against above sanction is incurred only on the EAP works under JICA entrusted to NHAI by the Ministry.

5. The accounts of National Highways Authority of India (NHAI) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.

6. Compliance of the provisions of OM (F.No.12(13)-B(W&M)/2020) dated 25.05.2022 issued by Budget Division, Department of Economic Affairs, Ministry of Finance, has been ensured.”.
