Ref. - (i) Planning Zone OMs of even nos. dated 02.05.22 and 09.05.22 (ii) Ministry's letter no. NH-15017/25/2021-P&M dated 11.08.2021

In supersession of Planning Zone OMs under ref. (i) on the subject cited above, Competent Authority has approved the sanction ceiling for NH(O) Works for the FY 2022-23 for projects assigned with State/UT PWDs/ MoRT&H PIUs. State/UT wise approved sanction ceiling is annexed.

2.1. Project Zones / ROs may finalise the State/UT-wise Annual Plan size at 1.25 times of the above State/UT - wise sanction ceiling limits, except for North Eastern States.

2.2. The projects/works may be got sanctioned during FY 2022-23 within the above State/UT - wise sanction ceiling limits.

2.3. Project Zones / ROs are requested to ensure that, if the project stretch is totally confined within one or more adjoining tribal districts, then such projects should only be got sanctioned under NHO-TSP head. For project stretches in North Eastern States, sanction should be under NH(O)-NE head. All project Zones are requested to separately intimate the projects considered under the Annual Plan under NH(O)-TSP head.

2.4. Project Zones/ROs should ensure that projects/works approved under Bharatmala Pariyojana may be got sanctioned under Bharatmala / Bharatmala-TSP head only. In this context, reference is invited to the Ministry's letter cited under ref.(ii) above (Copy attached). No sanction ceiling is required for projects under Bharatmala scheme.

3. Sanction ceiling of Rs. 1,200 Cr. has been separately allowed for the Road Safety Zone, primarily for taking up rectification of black spots during the FY 2022-23. CE(RS) is requested to take up necessary action in this context.

4. Monitoring Zone is requested to compile the sanction status on monthly basis and inform the Planning Zone to keep a watch on the total sanctions issued.
