After release of this instant amount of **Rs.300.00 crore[total: Rs.1200 crore]** to NHIDCL, an amount of ₹ 315 crore is reserve/balance in the head of account.

4. It shall be ensured that the expenditure against above sanction is incurred only on the EAP works under JICA entrusted to NHIDCL by the Ministry.
