Madam/Sir,

In continuation of this Ministry's letter of even number dated 18<sup>th</sup> September, 2025, I am directed to convey the sanction of the President to allocate and release funds of Rs.150.00 crore (Rupees one hundred and fifty crore only) to **National Highways & Infrastructure Development Corporation Ltd. (NHIDCL)** under **NH(O)-General Scheme** for NH works entrusted to NHIDCL during the Financial Year 2025-26 as detailed below.

01 Works under Road Wing

3. There is total BE provision of ₹ 61,392.37 crore under NH(O)-General (from GBS) for the financial year 2025-26. Out of which Rs.34,462 crore has been allotted for States/UTs, Rs.18.95 crore to M/o Shipping, Rs.30.70 crore to M/o Railway/Govt of Bihar and Rs.24,700 crore has been allotted to NHA. After release of this amount of Rs.150 crore [Rs.1250 crore] to NHIDCL, an amount of ₹ 930.72 crore is reserve/balance in the head of account.

4. It shall be ensured that the expenditure against above sanction is incurred only on the NH works entrusted to NHIDCL by the Ministry.

5. The accounts of National Highways & Infrastructure Development Corporation Ltd. (NHIDCL) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.


