- Shri Kamakshya Priyadarsan (applicant of IOCL), i.e., the applicant, vide letter dated 16.01.2020 has submitted a proposal to this office on the above mentioned subject. The applicant is requesting relaxation from Ministry's guideline issued vide letter no. RW/NH-33023/19/99-DO.III dated 24.07.2013 with respect to an "intersection with Rural Roads/ approach roads to private and public properties" is at a distance of 233.36 m as against the norm of minimum distance 300 m.
- As per Ministry's OM No. RW/NH/33023/19/99/DO-III dated 16.03.2016, the Highway 2. Administrator will make available the relaxation proposal along with Form-A on the Ministry's website (morth.nic.in) to invite public comments, for a period of 60 days.
