

1. The bidder NCC Infraspac Pvt. Ltd has submitted self-evaluated technical score of Rs 252.27 Cr against criteria given under clause 2.2.2.2 ( 1 ) of RFP Document and his self-assessed score has been found to be less than threshold technical Capacity of Rs 277.56 Cr. **Therefore, the financial bid of of NCC Infraspac Pvt. Ltd cannot be considered for opening as per requirement of clause 3.2 of RFP.**
