

3. Committee took note of debarment of the firm M/s Highway Engineering Consultant by the Building Department, National Highway, State of Telangana vide their order dated 18.05.2017 (Copy enclosed) and same has been challenged by the firm in the High Court of Hyderabad. The High Court vide order dated 05.06.2017 & 19.07.2017 (Copy enclosed) has suspended the operation of the Telangana Government order dated 18.05.2017. Before considering the eligibility of the firm for their financial opening of the bid, latest update of the Court case has to be submitted by the consultant. Depending upon the outcome of the court decision then, the committee will decide further action in the matter on the notified date of opening of financial bids of all Consultants. Committee directed that the Consultants needs to submit the outcome/latest update of the above Court case before opening of financial bids. M/s Highway Engineering Consultant is directed to submit the latest update of above referred court cases before the evaluation committee at 05:00 PM on the date of opening of financial bids i.e 03.11.2017.
