

Please refer to Technical bids for subject tender opened in Ministry on 06.10.2017 and 11 (Eleven) firms have participated in the tender. As per approval of Competent Authority of Ministry, out of total eleven bidders participated in the tender, following ten bidders have been found technically responsive & the one bidder (M/s Kasana Builders Pvt. Ltd. –M/s Manisha Projects Pvt. Ltd., –M/s Anupam Construction Company –JV) has not been found technically responsive. The list of technically qualified bidders is as under:



The eligibility of the Joint Venture as well as members of the Joint Venture M/s Kasana Builders Pvt. Ltd. – M/s Manisha Projects Pvt. Ltd., – M/s Anupam Construction Company–JV, has been examined based on the documents uploaded on e-tendering portal and it was noted that lead partner, M/s Kasana Builders Pvt. Ltd., of the above JV has claimed threshold Technical capacity of Rs.68.40 Cr., which is less as per requirement of RFP Clause 2.2.2.2(i) i.e. Rs.377.454 Cr. As per Clause 2.2.2.2(ii) of RFP at least one similar work of 25% of estimated project cost i.e. Rs.104.85 Cr. shall have been completed by Lead Member & the Lead Member, M/s Kasana Builders Pvt. Ltd. has claimed maximum value of completed work Rs.65.22 Cr., which is less than that required (Rs.104.85 Cr.) as per RFP. The bidder (M/s Kasana Builders Pvt. Ltd. – M/s Manisha Projects Pvt. Ltd., – M/s Anupam Construction Company–JV), therefore, fails the eligibility requirements for threshold Technical capacity as specified in Clause 2.2.2.2 (i) and Clause 2.2.2.2 (ii) of the RFP. Hence, **the financial bid of M/s Kasana Builders Pvt. Ltd. – M/s Manisha Projects Pvt. Ltd., – M/s Anupam Construction Company [JV] cannot be considered for opening as per requirement of Clause 3.2 of the RFP.**

2. As per requirement of Clause 3.2 of the RFP, above-mentioned 10 [Ten] technically responsive bidders are requested to inform this office through e-mail in the prescribed format enclosed at Annexure-VIA of Appendix-IA of RFP, for any change in their bid capacity, due to reward/declared to be the lowest bidder in any other project as on bid submission date. In case of no change, 'NIL' information shall be furnished. If any of the qualified bidders fails to furnish the above information due to whatsoever reasons, or fails to qualify in Bid Capacity in this changed scenario, his financial bid shall not be opened and online Financial Bids of the remaining bidders will be opened. The requisite information should be submitted to this office by 22.11.2017 up to 10:00 AM positively.
