Subject: Use of anti-stripping agent for bituminous layer -reg.

As per Ministry's Specification various tests are to be performed on aggregate bitumen and also on the bituminous mix. One of such test is coating and stripping of bitumen aggregate mix to ensure proper bonding of aggregate and bitumen. As per Ministry's Specification ,coating and stripping of bitumen aggregate mix is to be performed in accordance with IS 6241. In case the coating and stripping of bitumen aggregate mix is less than 95% ,anti-stripping agent is to be used. The requirement including the test to be performed for anti-stripping agent for bitumen addition has been prescribed in IS 14982:2017.

2. It is requested to ensure that the Concessionaire/Contractor, while designing the bituminous mix, should conduct the coating and stripping of bitumen aggregate mix and should use anti-stripping agent in case coating and stripping of bitumen aggregate mix is less than 95%. The anti-stripping agent should conform to the requirement as stipulated in IS 14982:2017.
