Notice Inviting Public Comments on laying of 220 KV underground electrical cable of 1200 sq.mm along NH - 275 (Bantwala - Bangalore section) from Km 326.800 to 329.650 for a length of 2850 m, on RHS by Open Trenching Method.

The Executive Engineer, NH Division, Bangalore vide letter cited under reference above, has submitted a proposal seeking permission for laying of 220 KV underground electrical cable of 1200 sq.mm along NH - 275 (Bantwala - Bangalore section) from Km 326.800 to 329.650 for a length of 2850m, on RHS by Open Trenching Method.
