Subject: Time limit for arbitral award - extension reg.

Sir/Madam,

Section 23 (4) of The Arbitration and Conciliation Act, 1996 stipulates that the statement of claim and defense shall be completed within a period of six months from the date the arbitrator(s) received notice in writing of their appointment. Section 29A (1) stipulate that the award shall be made by the arbitral tribunal within a period of twelve months from completion of pleadings under section 23(4). Further, section 29A (3) stipulates that the parties may, by consent, extend the aforementioned period for making award for a further period not exceeding six months.

- 2. Further, section 29A (4) stipulates that if the award is not made within the period specified in section 29A (1) or the extended period specified under section 29A (3), the mandate of the arbitrator(s) shall terminate unless the Court has, either prior to or after the expiry of the period so specified, extended the period. Provided further that where an application under sub-section (5) is pending, the mandate of the arbitrator shall continue till the disposal of the said application.
- 3. Delays have been observed in processing of cases of extension of mandate of Arbitration Tribunals and therefore Competent Authority has approved following timelines for processing of such cases:
- 3.1 For seeking extension of time limit under section 29A (3), concerned Regional Officer (RO) shall forward the proposal to the zone in Ministry Headquarters for approval of DG

- (RD) & SS, at least one month before completion of period specified under section 29A (1).
- 3.2 If extension of time limit is required under section 29A (4) and such application is required to be filed on behalf of the Authority in the Hon'ble High Court; the proposal for the same alongwith all relevant details, causes and justifications to be submitted to the zone in Ministry's headquarters at least 2 months prior to the completion of period under section 29A (3).
- 4. This issues with the approval of Competent Authority.
