  - (iii) Rationalisation of TDS rates for transport sector;
  - (iv) Rationalisation of rates of presumptive Income tax on transport vehicles;
  - (v) Facilitation of Seamless travel across the State borders and highways;
  - (vi) Direct Port delivery to ensure fair and equitable participation;
  - (vii) Feasibility of providing health services under ESIC to the drivers and coworkers of the commercial vehicles;
