
**Expression of Interest**

**Subject: Expression of Interest from eminent experts for empanelment as member of Expert Advisory Group in the Ministry of Road Transport and Highways to advise on matters related to road transport, including automotive sector**

1. The Ministry of Road Transport and Highways intends to constitute a non-profitable Expert Advisory Group (EAG) to advise the Ministry in formulating strategies and policies regarding road transport, including the automotive sector.
2. The EAG shall consist of 5 members, who would be eminent experts (individuals) in domains related to automotive and road transport sector. The terms of domain expertise of the EAG shall comprise, but not be limited to, providing expert advise on the following matters:
  - Use of Alternate Fuel, Hydrogen Fuel Cell, Bio-Fuels (Ethanol, Methanol Blends), etc
  - Electric Vehicles
  - Design and Safety of Vehicles plying on roads in India and formulation of rules for upgradation as per European/International Standards
  - Fuel Efficiency of various categories of vehicles
  - Vehicle emission standards
  - Study on Shared mobility, latest mobility initiatives (Hyper loop, Cable Propelled Transit etc.) and recommendation of future action plan
  - Central Motor Vehicle Rules and regulations.
  - Autonomous Vehicles (driver-less vehicles).
  - Automotive Components
3. The EAG shall meet (in Person/ through VC) once in 45 days or whenever required. Agenda for the meeting will be shared with the members by Transport Division/MVL section beforehand. Secretarial assistance for the functioning of the Expert Advisory Group will be provided by US (Transport)/US (MVL).

4. The members shall make their own arrangement for travel, accommodation, transport etc. The expenditure incurred on travel and accommodation will be reimbursed as per entitlement for Eminent personalities nominated as Non-officials in the Committees/Boards/Panels given in letter no. 19047 /1 /2016- E. IV dated 14.09.2017 issued by the Ministry of Finance.
5. The members will be provided a sitting fee as per GOI, Ministry of Finance, Department of Expenditure OM No. 19047/10/2016-E.IV dated 12.04.2017.
6. The Ministry therefore invites applications from Expert(s) with experience in the domain areas to [eag.morth@gmail.com](mailto:eag.morth@gmail.com) for empanelment to the EAG within 21 days from the date of publication i.e. by 25.10.2021
7. Members of Expert Advisory Group (EAG) having domain expertise will be engaged on Search cum Selection basis.
8. Domain Expert(s) shall ensure that there should be no conflict of interest in their engagement with EAG during the period. They should possess very high integrity and maintain confidentiality.
