Dearsh. R. S. Syrol,

Government has approved roll out of a pan India exclusive OFC based network for Defence Services in lieu of spectrum being released by MoD. This project is being implemented by BSNL in "Mission Mode" to meet the stringent timeline for release of spectrum. Any delay in network roll out activities for Defence OFC Network is likely have adverse effect on exploitation of C4ISR and all other Mission critical capabilities of Armed Forces. Therefore, the implementation of "Defence OFC Network" in a time bound manner is of national importance.

- 2. BSNL has initiated the tendering process for procurement and laying of 57,000 km of exclusive OFC for Defence network on 23 April 2010 as part of this project. The purchase order for laying of OFC for Defence network is likely to be issued in August 2010 and the laying of 57,000 Km OFC in all parts of the country is to be completed by March 2012.
- 3. Expeditious issue of Right of Way (RoW) clearance for all the Defence OFC routes is required to be obtained from various Central/State Govt agencies by October 2010. It is necessary to avoid delay in implementation of this vital project of national importance. BSNL will ensure completion of necessary reinstatement works during the installation of OFC routes for this project.
- 4. It is, therefore, requested that necessary instructions may be given to all agencies to facilitate expeditious RoW clearance to BSNL for Defence OFC routes.
