Interlocking Concrete Block pavements are being extensively used on the urban roads, footpaths, parking areas, lay byes etc. as a new approach in the construction of pavement. The Indian Roads Congress (IRC) have already published the Code, IRC:SP:63 for the design and construction of such pavements.

2. Considering the advantages and limitations of interlocking concrete block pavements, as brought out in IRC:SP:63, the interlocking concrete blocks may be considered for use along the National Highway stretches in built-up areas. If required, these may be adopted for use in the kerbs and footpaths also.
