It is brought to the notice of all that Mr. Jainendra Kumar Tiwari was selected as Team Leader cum Senior Highway Engineer by, M/s AECOM Asia Company Limited JV with M/s G Eng Advisory Services Private Limited in association with M/s Shree Bhawani Consultancy Service Pvt. Ltd. for the work of "Consultancy Services for Authority's Engineer for Supervision of "4-Laning of Itanagar to Banderdewa section of NH-415 from km 40+430 to km 51+735 (Package-B) and Km 51+700 to Km 59+199 (Package-C) on EPC Mode in the state of Arunachal Pradesh"".

The Authority's Engineer vide letter no AECOM/AP/Ita-Band/NH-415/2024/1439 dated 29.08.2024 has informed that Mr. Jainendra Kumar Tiwari was deployed on the project site after approval accorded by the Authority vide letter no. 415/Ar.P/2020-21/032/AE/RO-Ita/10771-73 dated 07.10.2022. 
