Modification in Delegation of powers for Formulation, Appraisal and Approval in respect of National Highways Projects.

The undersigned is directed to refer to the Ministry of Finance, Department of Economic Affairs OM No. 1/22/2012-PPP dated 09.07.2013 on the subject mentioned above and to say that Cabinet Committee of Economic Affairs (CCEA), in its meeting held on 09/07/2014 [Case No. 112/CCEA/2014], had increased the threshold for approval of cases recommended by Public Private Partnership Appraisal Committee (PPPAC) from ₹ 500 crore to ₹ 1000 crore. The Committee further directed that the procedure and the threshold for clearance of Public Private Partnership projects at levels below the Cabinet/CCEA, be reviewed and laid down with the approval of the Minister of Finance. A copy of the CCEA's decision dated 09/07/2014 is enclosed.

2. Ministry of Finance has now concurred that all projects within the Total Project Cost (TPC) of ₹ 1000 crore would henceforth be appraised by a Committee headed by Secretary (RT&H) with representatives of the Planning Commission and the Ministry of Finance (Department of Expenditure in case of Public Funded Projects and Department of Economic Affairs in case of PPP Projects) and approved by Minister (RT&H).
