**Subject:** Segregation of Civil Construction Cost from Capital Cost of National Highways (NH) Projects for appraisal and approval -reg.

In continuation of the Department of Economic Affairs' O.M No. 1/22/2012-PPP dated 12<sup>th</sup> March, 2015 and Department of Expenditure's O.M No. 24(35)/PF-II/2012 dated 29<sup>th</sup> August, 2014 regarding delegation of powers for appraisal and approval of National Highways (NH) projects, Cabinet Committee of Economic Affairs (CCEA), in its meeting held on 18/11/2015 {Case No. 113/CCEA/2015}, has approved to segregate construction cost from cost for land acquisition, centages and pre-construction activities for the purpose of appraisal and approval of NH projects.

2. The CCEA has further approved the following:-

- i) All NH projects with a Civil Construction Cost of up to Rs. 1000 crores shall be appraised by SFC/EFC/PIB headed by Secretary (RT&H) and approved by Minister (RT&H).
- ii) All NH projects with a Civil Construction Cost above Rs. 1000 crores shall be appraised by PPPAC/EFC/PIB headed by Secretary, Department of Economic Affairs/Expenditure and approved by CCEA.
