

- ~~3.~~ In view of above, it is again reiterated that Regional Officer of concerned implementing agency must inspect the site for examining the provisions proposed by DPR consultant as well as inspection report for the same will be pre-requisite for processing project proposals for Appraisal and Administrative & Financial approval.
