**Subject: PM GatiShakti National Master Plan - SOP and standard format of proposals to NPG - Additional Information to be furnished for consultation of NHs Projects in the Network Planning Group (NPG) - Regarding**

Email dated 02<sup>nd</sup> December by CE (PL) to all Concerned: Minutes of 35th meeting of Network Planning Group (NPG) held on 28.10.2022 - Actionable issues and features to be covered under Projects to be presented to Network Planning Group under PM GatiShakti NMP reg.

Undersigned is directed to draw reference to the revised SOP and standard format for submission of proposals for consultation of NHs Projects in the Network Planning Group (NPG) circulated to all concerned vide O.M. of even no., dated 25.08.2022, O.M. No. NH-15017/Oct/2022-DNT dated 11.10.2022 and intimated that during the recent meeting of the NPG held on 28.10.2022, it has been desired that: -

*"For the projects submitted subsequently by Ministries, the submission should include the advantages which the project will accrue to the industries and economic activities in the region. The Ministry/Deptt should explain how the project will contribute to multimodal connectivity, connect manufacturing and economic zones to infrastructural connectivity, etc. Compliance to GatiShakti concept is critical, and accordingly it is required to justify the GatiShakti concept fulfilment."*

2. During the process of consultation on one project of the Ministry / NHAI in Karnataka State in the subsequent meeting of the NPG held on 30.11.2022, it was desired that henceforth: -

- (i) the above aspect (Ref. para 1 above) be also addressed in detail for the NHs / other projects to be consulted in the NPG;
- (ii) details shall be shared regarding -
  - (a) specific types of commodity and estimated commodity quantity (in Metric Tons) likely to be generated from economic nodes / zones / clusters / ports, etc. (as

are relevant), specific NHs / road corridors to be used and their end destinations;

(b) analytical substantiation of reduced logistics cost with the Project scenario;

(c) estimated traffic likely to be induced along with probable traffic distribution and its impact on NHs corridors (both on the project corridor being discussed in the NPG and other adjacent NHs corridors) on account of the above.

3. It is pertinent to mention that the above details are expected to be covered in the Project Reports of the NHs proposals by the DPR Consultants. Also, DPR Consultants may be requested to provide the above details for the projects for which DPR is completed and will soon be presented to NPG for Consultation.

4. All concerned are accordingly requested to take note of the same for needful incorporation in NHs / other projects being presented to NPG henceforth.

5. It is requested to bring the contents of this reference into the notice of all concerned for needful compliance.
