3. The procedure for invitation of tender and award of works stipulated vide this Ministry's letter no. RW/NH-24035/4/2008-P&M/PIC dated 27.11.09 and subsequent modification dated 21.05.10 shall be followed in respect of the works sanctioned under CRF schemes which have not been awarded before 27.11.09. Further this Ministry's Standard Bidding Document (SBD) shall also be followed for all such works costing Rs. 5 crore and above. These stipulations shall also be applicable for the CRF works sanctioned subsequent to 31.03.2010 until further orders.
